

STEP is an insurance product designed to help families obtain reimbursement for their pre-paid, non-refundable youth sports tuition and fees, should a covered event occur. STEP benefits both the athlete's family, by providing possible financial reimbursement, and the sports organization, by helping to leave their budgets intact. The relationship between the organization and family is greatly improved and, as an ancillary benefit, this may help alleviate the pressure of rushing back to the team so the athlete can rehabilitate properly. STEP benefits may be available if an athlete or a close family member is severely injured or sick and as a result the athlete cannot play all or a portion of the season as determined by a physician. There also may be coverage available in the event the family is relocated or moves and can no longer participate in the sport.
